VEEV NOW™ Model M0012:

- Step 1: Check the Voltage. The device should be fully discharged before disassembling it.
- Step 2: Insert a screw driver at the bottom of the device between the aluminum tube and the end cap and pull out the battery holder half way through until the white silicon ring
- Step 3: Use cutting pliers to cut the battery tabs
- Step 4: Insert a screw driver at the bottom between the battery and the battery holder. Lift the battery and take it out
